LUNG DISEASE EDUCATION - IN 2020-21 BREATHE PA'S SCHOOL ASTHMA INITIATIVE PROVIDED SCHOOL AND COMMUNITY-BASED ASTHMA EDUCATION IN 4 SCHOOL DISTRICTS (4 SCHOOLS), DISTRIBUTED 23 STUDENT ASTHMA TOOL KITS TO FAMILIES OF CHILDREN WITH ASTHMA AND TRAINED 59 PROFESSIONAL STUDENTS IN THE FIELD OF NURSING OR RESPIRATORY CARE. BREATHE PA ASTHMA CEU CLASS "CURRENT ASTHMA CLASSIFICATION/TREATMENT GUIDELINES AND BREATH SOUNDS TRAINING WAS COMPLETED BY 83 SCHOOL NURSES REPRESENTING 94 SCHOOLS (27 DISTRICTS) AND 1 UNIVERSITY, ISSUING NURSES A TOTAL OF 81 CEUS.
