THE FAMILIES COLLECTIVELY SERVED OVER 21,770 COMMUNITY SERVICE HOURS TO EARN THEIR HOMES, MAKING A SIGNIFICANT IMPACT IN THEIR COMMUNITIES. THE SAFETY, SECURITY, AND PEACE PROVIDED BY ADEQUATE SHELTER ARE FUNDAMENTAL FOR A HEALTHY LIFE. THE HOMES SERVE AS AN ESSENTIAL FOUNDATION ON WHICH MORE COMPREHENSIVE, HUMAN, AND SUSTAINABLE COMMUNITY DEVELOPMENT PROGRAMS ARE BUILT UPON. THE HOUSE RECIPIENTS ARE PROVIDED WITH A 'STARTER HOME' THAT PROVIDES THE FAMILY WITH AN ASSET (EQUITY) THAT THEY DIDN'T PREVIOUSLY HAVE.
