Other	Part III - Statement of Program Service Accomplishments - Emgage continued with its core work of educating voters on key issues that affect them. We also connected constituents with elected officials. Our Michigan chapter had its first virtual advocacy day, during which they hosted the Governor, Secretary of State, and Attorney General to discuss criminal justice reform, COVID-19 response, and voting rights. In New York, our team hosted its first Muslim Day at City Hall, a virtual conference in which over thirty city council members and their staff discussed civil rights and incarceration, social services, domestic violence, immigration, small business growth, and youth empowerment. Our Pennsylvania and Florida chapters held similar civic engagements including townhalls and iftars to promote engagement between Muslim American communities and their elected officials. Our chapters also focused on redistricting to ensure that minority voters were properly represented. In Texas, our team provided extensive legislative testimony showing that redistricting in the state was racially motivated and rooted in voter suppression. We are so proud of the incredible work that our national and state chapters have done to ensure that Muslim American communities are an empowered, civically engaged community- and that we are fairly represented in government and policy-making processes.
