THE FOUNDATION IS ABLE TO MAKE A DIFFERENCE THROUGH ACTIVELY LISTENING TO THE NEEDS OF OTHERS PROVIDING THE NECESSARY SUPPORT AND REFERRING THESE INDIVIDUALS TO THE VERY BEST PROFESSIONALS AND ORGANIZATIONS FOR FURTHER ASSISTANCE. AS OF 2016, THE FOUNDATION STARTED PROVIDING COUNSELING TO YOUTH AND THEIR FAMILIES NEGATIVELY AFFECTED BY BULLYING, CYBERBULLYING, AND SUICIDE. DURING THE 2020-2021 FISCAL YEAR, THE FOUNDATION PROVIDED THE FOLLOWING SUPPORTS: 26 STUDENTS, INDIVIDUALS, AND ORGANIZATIONS RECEIVED INFORMATION, INTERVIEWS, OR CONSULTATIONS FOR PERSONAL PROJECTS FOR 3729 MINUTES OR 62 HOURS. THE RESOURCE CENTER HAS IMPACTED 71 INDIVIDUALS AND FAMILIES NEGATIVELY IMPACTED BY ISSUES SURROUNDING BULLYING, CYBERBULLYING, AND SUICIDE. STAFF WORKED WITH THESE INDIVIDUALS FOR A TOTAL OF 7088 MINUTES OR 118.1 HOURS. ON AVERAGE, STAFF SPENT 99.6 MINUTES, OR 1.66 HOURS WITH EACH INDIVIDUAL. THE FOUNDATION PROVIDES COUNSELING SERVICES. DURING 2020-2021, 30 YOUTH AND THEIR FAMILIES RECEIVED COUNSELING SERVICES. THERE WAS AN AVERAGE OF 8 SESSIONS TOTAL PER YOUTH WITH 218 UNITS OF COUNSELING PROVIDED. 100% SHOWED IMPROVEMENT IN SYMPTOMS AND ENGAGEMENT WITH PEERS, AND A DECREASE IN ANXIETY AND DEPRESSION, FEWER THOUGHTS OF SUICIDE, AND AN INCREASED SENSE OF HOPE AND OPTIMISM.
