Community Organizing: WRAP members identify issues of concern to homeless people through street outreach. WRAP member groups then work for change on the issues identified. In 2021, WRAP members focused on some of the laws that criminalize people attempting to survive unhoused. Our member groups continue to join together in an effort to stop this criminalization.

4b (Code:) (Expenses \$ 38,498 including grants of \$ 0) (Revenue \$ 0)

Public Education: WRAP members engaged in public education through speaking at community meetings, writing op-eds, and presenting at conferences and universities. WRAP also created 10 new pieces of art work, published 20 newsletters and convened 24 member meetings.

Legal and Policy: WRAP members continue to attempt to make change at the federal, state, and local level, with a focus on policies that increase homelessness numbers and make it more difficult for people to survive unhoused. WRAP is also working with other organizations to develop legal clinics for homeless people to access legal representation.
