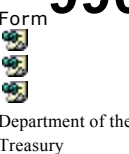

OUR AGENDA IS BASED AROUND A RANGE OF ISSUES AFFECTING WORKING PEOPLE AND THEIR COMMUNITIES THAT INCLUDE HEALTH CARE, CLEAN ENERGY, HOUSING, IMMIGRATION, ACCESS AND AFFORDABILITY TO HIGHER EDUCATION, AND THE OVERDOSE CRISIS AND ISSUES RELATED TO CRIMINALIZATION OF THESE COMMUNITIES. POLITICAL - THE ORGANIZATION ENGAGES IN THE ELECTORAL PROCESS BY SUPPORTING CANDIDATES ALIGNED WITH OUR ORGANIZATIONAL MISSION, OUR ISSUE-BASED AGENDA AND VISION FOR THE COUNTRY.
