THE WOODS PROJECT PROVIDES HOUSTON HIGH SCHOOL STUDENTS FROM LOW-INCOME COMMUNITIES WITH TRANSFORMATIVE, EXPERIENTIAL LEARNING OPPORTUNITIES IN THE OUTDOORS WHICH ARE DESIGNED TO HELP THEM DEVELOP THE LIFE AND LEADERSHIP SKILLS (GRIT/PERSEVERANCE, ADAPTABILITY, CRITICAL THINKING, ZEST/CURIOSITY, SOCIAL INTELLIGENCE, INDEPENDENCE/SELF-CONTROL, AND ENVIRONMENTAL AWARENESS) THAT CORRELATE STRONGLY WITH SUCCESS IN SCHOOL, THE WORKPLACE AND LIFE. TWP OFFERS THREE MAIN PROGRAMS: WEEKLY AFTER-SCHOOL CLUBS, WEEKEND OVERNIGHT CAMPING TRIPS, AND TWO-WEEK WILDERNESS IMMERSION SUMMER TRIPS TO NATIONAL PARKS AND OTHER COMPARABLE OUTDOOR AREAS. 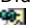
