IN ADDITION TO PROVIDING HOUSING, TRAINING AND MEDICAL CARE FOR THE ANIMALS IN ITS CARE WHILE THEIR OWNERS ARE BEING LOCATED OR WAITING FOR ADOPTION, HSJC PROVIDES OTHER COMMUNITY SERVICES.
