THIS PAST YEAR WE SERVED INDIVIDUALS FROM 26 COUNTIES (OUT OF A TOTAL OF 33) IN NEW MEXICO AND PROVIDED DIRECT REPRESENTATION, ADVICE, BRIEF SERVICES AND NAVIGATION, AND LEGAL INFORMATION AND REFERRAL TO 5,161 INDIVIDUALS. DUE TO THE PANDEMIC, WE CREATED A REMOTE LEGAL SERVICE INFRASTRUCTURE TO PROVIDE BRIEF SERVICES SUPPORT TO INDIVIDUALS APPLYING FOR CITIZENSHIP, GREEN CARD RENEWAL AND WORK PERMIT RENEWAL. WE ALSO DEVELOPED A REMOTE SERVICE INFRASTRUCTURE TO PROVIDE LEGAL ORIENTATION AND BRIEF SERVICES TO DETAINED IMMIGRANTS AND ASYLUM SEEKERS FACING REMOVAL.
