Agency long-term care ombudsmen provided information and assistance with 2,271 issues and problems related to long-term care, including care plans, abuse, restraints, lost or stolen belongings, quality of care, misappropriation of funds, transfers and discharges, and long-term care facility selection. This program utilized \$37,943 of donated services.
