COMMUNICATIONS - IN 2021, CONVERGENCE LAUNCHED MULTIPLE NEW DIALOGUES, BRINGING INDIVIDUALS AND ORGANIZATIONS TOGETHER ACROSS IDEOLOGICAL DIVIDES TO SOLVE CRITICAL PROBLEMS, INCLUDING THOSE FOCUSING ON ECONOMIC RECOVERY FROM THE PANDEMIC, REIMAGINING CARE FOR OLDER ADULTS, MODERNIZING THE CIVIL SERVICE, AND REDUCING DIGITAL DISINFORMATION.
