CILC provided direct legal representation to low-income Dane County individuals at risk of deportation. Most cases were initiated while clients were in the custody of the Dept. of Homeland Security and required litigation at US Immigration Court in Chicago. CILC opened 20 new cases in 2021.

4b (Code:) (Expenses \$ 2,000 including grants of \$) (Revenue \$)

CILC provided free clinics allowing members of the public to consult one-on-one with an immigration attorney on immigration-related legal issues and to be referred to a local low-bono immigration attorney where appropriate. Clinics were conducted on the 2nd and 4th Friday of each month. In 2021, CILC's clinics provided consultations to an estimated 223 individuals, families, and students. CILC maintained a list of volunteer attorneys who rotated participation at the Friday clinics and a separate list of attorneys willing to accept referrals on a low-bono basis.

CILC provided informed speakers to local groups (such as churches, schools, and advocacy organizations) interested in learning about and discussing current immigration issues affecting our community. Speakers included CILC-employed staff attorneys and non-employee volunteer attorneys from the Madison area, including CILC board members. CILC made an estimated 10 presentations in 2021, including radio program outreach.
