SOME EXAMPLES OF IMPORTANT VICTORIES FAC ACHIEVED IN 2021: - FAC FORCED THE DISCLOSURE OF THOUSANDS OF PAGES OF FORMERLY SECRET RECORDS OF POLICE-MISCONDUCT INVESTIGATIONS PART OF FAC'S LARGER CAMPAIGN TO ENFORCE AND STRENGTHEN CALIFORNIA'S SB 1421, A LANDMARK BILL THAT BROUGHT LONG-NEEDED TRANSPARENCY TO SUCH RECORDS.
