THE FOUNDATION FOR THE CHILDREN IS PART OF AN INTERNATIONAL VENTURE DEDICATED TO SUPPORT HOSPITAL INFANTIL AND ITS MISSION OF IMPROVING THE HEALTH OF CHILDREN FROM ACROSS THE REGION OF SOUTHERN CALIFORNIA AND NORTHERN BAJA CALIFORNIA, BY PROVIDING AFFORDABLE MEDICAL, NUTRITIONAL, AND DENTAL CARE AS WELL AS HEALTH AND NUTRITION EDUCATION. WITH THE SUPPORT OF THE FOUNDATION FOR THE CHILDREN, THE FOUNDATIONS IN MEXICO AND CANADA, AND THE GENEROUS SUPPORT OF THE PUBLIC ACROSS THE REGION, CORPORATE SPONSORS AND PHILANTHROPISTS, HOSPITAL INFANTIL IS A MODEL PEDIATRIC SPECIALTY FACILITY THAT PROVIDES SERVICES TO CHILDREN FROM ACROSS THE REGION, REGARDLESS FOR THEIR ABILITY TO PAY FOR THE SERVICES. HOSPITAL INFANTIL SUCCEEDS IN DELIVERING AFFORDABLE CARE IN LARGE PART BECAUSE OF ITS UNIQUE OPERATING MODEL THAT IS BASED ON VOLUNTEERISM. IT IS AN OUTPATIENT FACILITY STAFFED BY VOLUNTEER PEDIATRIC SPECIALISTS AND CLINICIANS, SUPPORTED BY A CORE STAFF OF PEDIATRICIANS AND INFRASTRUCTURE PERSONNEL. THE FOUNDATION FOR THE CHILDREN PROVIDES FINANCIAL SUPPORT FOR HOSPITAL INFANTIL FOR CAPITAL NEEDS, INNOVATIVE PROJECTS AND FOR ITS PAPI PROGRAM WHICH FUNDS MEDICAL CARE FOR CHILDREN NOT ABLE TO AFFORD CARE. AS OF 2021, HOSPITAL INFANTIL HAS PROVIDED OVER 700,000 PEDIATRIC CONSULTATIONS, MORE THAN 20,000 SURGERIES, AND OVER 500,000 HOURS OF SERVICE BY VOLUNTEERS FROM THE US, CANADA AND MEXICO.
