Through a comprehensive Graduate Support Program, we help our students transition to and succeed at a top regional high school and then matriculate to college or university. IN PARTNERSHIP WITH OUR FAMILIES, WE ARE COMMITTED TO EACH STUDENTS TOTAL DEVELOPMENT, ACADEMIC, SOCIAL, PHYSICAL, SPIRITUAL AND EMOTIONAL BY EMPHASIZING SERIOUS STUDY AND PERSONAL AND SOCIAL RESPONSIBILITY. Our Middle School provides an extended day, extended year program serving 6th to 8th grade low-income, first-generation college bound students and their families to ensure the students are prepared to excel in high school, college, and beyond. Our students attend school daily from 8:00 a.m. until 5:00 p.m. each day. The following is a brief outline of our extended day: Each content-area class is scheduled for 60 to 90 minutes each day. Our daily afternoon study hall is structured time for students to begin their home assignments and to work with teachers, if needed, for additional help. Breakfast, lunch, and an afternoon snack are offered for each student each day. Our weekly schedule includes a tutorial period, a time set aside for silent reading or for students to meet with teachers or with tutors for additional academic support. Our academic schedule is year-round Beginning in September and going through June, students attend for nine hours a day, and then return from early July through mid-August with our four-week summer semester.
