ADDITIONALLY, MINNETRISTA OPENED THE SHORT-TERM ORIGINAL EXHIBITION, JARRING OUR MEMORIES, AND TWO LONG-TERM EXHIBITS, BOB ROSS EXPERIENCE AND OAKHURST EXPERIENCE, CONTINUED TO DELIGHT LOCAL, REGIONAL, AND TOURIST AUDIENCES. THE MINNETRISTA HERITAGE COLLECTION INCLUDES ARTIFACTS, ART, AND ARCHIVAL MATERIAL THAT DOCUMENT THE PEOPLE, PLACES, ORGANIZATIONS, EVENTS, AND BUSINESSES AND INDUSTRIES OF EAST CENTRAL INDIANA. A MAJOR COMPONENT OF THE COLLECTION IS BALL FAMILY MATERIAL AND BALL CORPORATION BUSINESS RECORDS. SEVERAL ACQUISITIONS RECEIVED IN 2021 ENHANCE THE EXISTING BALL BUSINESS COLLECTION AND INCLUDED BALL-MADE PRODUCTS SUCH AS FRUIT JARS, ACRYLIC PRODUCTS, AND OTHER CANNING RELATED PRODUCTS. OTHER BALL-RELATED ARTIFACTS INCLUDE NEWSLETTERS, ADVERTISING MATERIALS, POSTERS, AND OTHER ARCHIVAL ITEMS. THE MINNETRISTA HERITAGE COLLECTION, BOTH ON-SITE AND ON-LINE, IS ALSO A DESTINATION FOR RESEARCHERS. IN 2021, THERE WERE MORE THAN 181 REMOTE AND IN-PERSON RESEARCH REQUESTS AND APPOINTMENTS. BY THE END OF THE YEAR, THERE WERE MORE THAN 7,500 ARTIFACTS; 6,271 PHOTOGRAPHS; AND 2,452 ARCHIVAL RECORDS FROM THE MINNETRISTA HERITAGE COLLECTION ON-LINE. THOUSANDS OF ADDITIONAL RECORDS WERE AVAILABLE ONSITE TO RESEARCHERS THROUGH OUR COLLECTIONS MANAGEMENT SYSTEM. THERE WERE APPROXIMATELY 12,800 SEARCHES OF THE ON-LINE COLLECTION IN 2021.
