THE FOUR ISSUES OF YOUNG CHILDREN CONTAINED CLUSTERS OF ARTICLES ADDRESSING THE FOLLOWING TOPICS: FOSTERING CONTENT KNOWLEDGE THROUGH INTEGRATION; USING A KNOWLEDGE-RICH CURRICULUM TO SUPPORT IDENTITY DEVELOPMENT AND ADVANCE EQUITY; SOCIAL AND EMOTIONAL DEVELOPMENT FOR THE YOUNGEST LEARNERS; AND NURTURING EQUITY LEADERS.

THE CONFERENCE ALSO FOCUSED ON THE RELEASE OF NAEYC'S NEW POSITION STATEMENT, DEVELOPMENTALLY APPROPRIATE PRACTICE (DAP). NAEYC'S PUBLIC POLICY FORUM ALSO TOOK PLACE VIRTUALLY WITH MORE THAN 800 EDUCATORS AND ADVOCATES FROM ALL 50 STATES AND THE DISTRICT OF COLUMBIA. IT WAS TWO DAYS OF NEARLY 20 INFORMATIVE, INTERACTIVE, AND RECORDED SESSIONS WITH EARLY CHILDHOOD POLICY EXPERTS FOLLOWED BY MULTIPLE DAYS OF VIRTUAL VISITS WITH CONGRESSIONAL MEMBERS AND STAFFERS.
