OUR SKILLED BIOLOGISTS AND IDENTIFICATION EXPERTS CONDUCT SEASONAL SURVEYS OF MIGRATORY WATERBIRDS AND LANDBIRDS AT WHITEFISH POINT BIRD OBSERVATORY, AND WE COLLABORATE WITH GROUPS LIKE THE U.S. FISH AND WILDLIFE SERVICE, AVIAN KNOWLEDGE NETWORK, HAWK MIGRATION ASSOCIATION OF NORTH AMERICA, GRADUATE STUDENTS, AND COMMUNITY SCIENTISTS.
