28 Part III School Workshops 500 public school students and teachers from underserved Title I schools in primary grades attend field trips during the school day and engage in art education and environmental stewardship through recycled materials and creative reuse. Students take projects home and display them in the community. Upper grades engage multiple times per school year. Starting in mid March 2020 through 2021, in person workshops were conducted remotely through development and use of art activity kits with instruction via Zoom. This program area was approximately 85 percent of organization expenses.

29 School Break Sessions. Approximately 150 students attend all day workshops of art education with creative reuse in the Art FORM studio. Workshop attendance is approximately 65 to 75 percent fee based and 25-35 percent scholarship based for underserved public school students from the immediate mid City community who attended. Workshops were suspended in 2020 and began slowly in 2021 due to the Covid 19 pandemic. This program area represented use of approximately five percent of organization expenses.

30 Community Outreach Events and Programs. Public engagement through large community events such as Earth Day as in prior non-Covid years and partnership with the San Diego River Park Foundation continued. Additional outreach through creative reuse store, where teachers, students and the community members can source recycled materials for art and craft projects for free or with a donation occurred but were still more limited than in typical non Covid years. The community, business and industry can donate recycled materials redirecting them from landfills to create projects within the community. This program area represents approximately 10 percent of the organization's expenses.
