THE FOUNDATION GENERALLY HOLDS TWO MAJOR FUNDRAISING EVENTS ANNUALLY, A 5.7K RACE FOR ALS AND A SOIREE WITH O.J. THESE EVENTS RAISE FUNDS TO SUPPORT THE MISSION AS WELL AS INCREASE AWARENESS ABOUT ALS IN THE COMMUNITY. DUE TO THE PANDEMIC IN 2021, THE FOUNDATION HELD A VIRTUAL RACE FOR ITS FUNDRAISING EVENT.
