SEARCHABLE BY ISSUE, LOCATION, AUTHOR, NEWSROOM AND STRATEGIC INSIGHTS, THIS DATABASE GREW IN 2021 TO INCLUDE MORE THAN 13,000 STORIES BY 6,000 JOURNALISTS ABOUT RESPONSES TO PROBLEMS IN 187 COUNTRIES.
