IN 2014 (THE ORGANIZATION'S FIRST FULL YEAR AS AN INDEPENDENT NON-PROFIT), THE ISSUE OF HIGH DRUG PRICES HIT THE NATIONAL STAGE WITH THE APPROVAL OF NEW CURES FOR HEPATITIS C PRICED AT \$1,000 PER PILL. AROUND THE SAME TIME, THE ORGANIZATION WAS FINE-TUNING ITS METHODOLOGY TO DETERMINE FAIR PRICES FOR PRESCRIPTION DRUGS. THE PUBLIC'S NEED FOR INDEPENDENT ANALYSES OF FAIR DRUG PRICES CAUSED THE ORGANIZATION TO GROW AT A FASTER PACE THAN IT WAS ABLE TO CULTIVATE NEW DONORS TO SUPPORT THE WORK, MEANING IT RELIED ON A FEW SELECT DONORS TO SUPPORT THE SCALING OF THE ORGANIZATION. THE ORGANIZATION HAS BEEN BUILDING ITS INFRASTRUCTURE AROUND THE PUBLIC NEED, NOT AROUND DONORS, WHICH HAS MEANT THE ORGANIZATION FAILED THE 33 1/3% TEST THIS YEAR. LATE IN 2018, THE ORGANIZATION ESTABLISHED A FUNDRAISING FUNCTION TO BE FOCUSED ON INCREASING THE NUMBER OF DONORS FROM THE GENERAL PUBLIC. IN 2019, ICER ADDED A 'DONATE' BUTTON TO ITS WEBSITE, AND ICER HAD AN INCREASE IN THE NUMBER OF INDIVIDUAL DONORS IN 2020 AND 2021, BRINGING ITS PUBLIC SUPPORT PERCENTAGE FROM 14.78% IN 2019 TO 23.77% IN 2020 TO 25.48% IN 2021. THE GOVERNANCE BOARD OF THE ORGANIZATION CONTINUES TO BE FOCUSED ON SUPPORTING THE PUBLIC'S INTEREST, AS WE HAVE THE PATIENT, CONSUMER, PROVIDER AND PAYER PERSPECTIVES REPRESENTED ON THE BOARD, ADVISING THE ORGANIZATION'S STRATEGIC PRIORITIES.
