Our expenses are directly related to their care and revenue is their adoption fees. * We have partnered with trappers to do trap/neuter/release services that has been at no expense to us nor has drawn in revenue. * We have been working with the community, educating and helping these families to continued to provide homes for their adoptees, working through issues that may have caused the family to return the cat or kitten.
