PRAISE BE TO GOD AND THANKS TO THOSE WHO GAVE 7 TEACHING CENTERS IN EAST/CENTRAL AFRICA, INCLUDING TWO NEW SITES. A DORMITORY FOR UP TO 180 STUDENTS IN KAPCHORWA. INCREASED THE POWER OF OUR RADIO STATION IN KAPCHORWA, UGANDA; AND PURCHASED ADDITIONAL STATIONS IN NIGERIA AND CAMEROON THROUGH THE MINISTRY OF GAL.COM THE NEW CLINIC AND LIBRARY/ADMINISTRATION BUILDING IN UGANDA ARE NEARING COMPLETION AND THE FACILITIES WILL BE DEDICATED ON FEBRUARY 28, 2022. A VAN WAS PURCHASED TO ALLOW US TO BRING STUDENTS AND FACULTY TO THE VARIOUS CAMPUSES. IN DAHLONEGA, GEORGIA, OUR NEW HEADQUARTERS BUILDING IS ABOUT HALF-FINISHED, AND THE DEDICATION IS SCHEDULED FOR SUMMER 2022. WE ARE EXCITED ABOUT PLANTING A NEW BRANCH OF THE ACCREDITED TRINITY BIBLICAL INSTITUTE IN TANZANIA. THE FIRST CLASSES HAVE ALREADY BEEN COMPLETED. OUR STUDENTS ARE BUSY PLANTING NEW CHURCHES AND RESTORING CHURCHES IN NEED. WE HAVE ASSISTED CHURCHES IN KAPCHORWA, SANSARA, AND SUAM/BUKWO THROUGH THE TRINITY NETWORK. WE HAVE EXPLORED THE POSSIBILITY OF NEW BRANCHES OF TBI IN BURUNDI, DRC, AND ETHIOPIA. WE IMPROVED THE WATER SUPPLY IN KAPCHORWA BY ADDING WATER TANKS. WE HAVE IMPROVED THE ELECTRICAL SYSTEM AT THE CAMPUS IN KAPCHORWA BY ADDING A LARGE GENERATOR. WE HAVE EXTENDED PEACE TO OUR MUSLIM NEIGHBORS IN KAPCHORWA THROUGH FRIENDSHIP, MEDICAL OUTREACHES, AND GOSPEL CONVERSATIONS.
