CITIZEN REDEFINED BRINGS TOGETHER GROUPS OF YOUNG PEOPLE, GUIDED BY AN ELDER, FOR AN ARC OF CIVIC AND ETHICAL FORMATION, CULMINATING IN A CIVIC REDEFINITION RITE OF PASSAGE. CITIZEN UNIVERSITY TRAINS EDUCATORS AND OTHER ADULT MENTORS FROM ACROSS SECTORS AND ACROSS THE COUNTRY TO FORM AND FACILITATE SMALL GROUPS OF HIGH SCHOOL-AGED PARTICIPANTS AS THEY DEVELOP THEIR IDENTITIES AS CITIZENS. IN ADDITION, OUR YOUTH COLLABORATORY STUDENTS HAVE THE OPPORTUNITY TO PARTICIPATE IN OUR NATIONAL CIVIC COLLABORATORY MEETINGS, OFFERING AN UNPARALLELED OPPORTUNITY FOR CROSS-GENERATIONAL RELATIONSHIP BUILDING, WHICH HAS LED TO SEVERAL NEW PARTNERSHIPS BETWEEN OUR YOUTH AND NATIONAL COLLABORATORY MEMBERS. AT OUR MEETINGS HELD IN CITIES AROUND THE US, INNOVATORS EXPERIMENT AND TEST NEW IDEAS, SHARE CUTTING-EDGE PROJECTS, AND FORM NORMS OF COLLABORATION AS THEY SUPPORT ONE ANOTHER IN THEIR WORK.
