We were able to host over 15 Palestine education centered events with over 500 attendees and at least 5 educational workshops.We had over 10 community centered events and workshops on topics such as health insurance, substance abuse, and college and job preparations.We have over 10 active educational and recreational programs that caters to over 180 families in our community. Our programs include basketball, soccer, arabic, English, dabka, tatreez, computer and citizenship prep. We offer programs to ages from 3 to 70.We redid the way we do programs by standardizing our schedules, focusing on quality over quantity and providing more flexibility.We started renovating PACCs office kitchen into a commercial kitchen that will host various Palestinian cooking classes and programs.We launched a new logo and branding for PACC. We held our first large in person event through our annual Arab Fair where we had over 1,000 people attend. We held our virtual annual conference.
