OUR EXPERT PHYSICIAN VOLUNTEERS PROVIDED 4,887 MEDICAL CONSULTS TO FRONTLINE PROVIDERS AT PARTNER CLINICS AROUND THE U.S., A 43% INCREASE OVER 2020. ADDITIONALLY, VOLUNTEERS PROVIDED 534 HOURS OF MENTORING (COMPARED TO 413 IN 2020) AND HOSTED MORE THAN 4,459 ATTENDEES FOR MEDICAL EDUCATION WEBINARS ON A VARIETY OF HOT TOPICS (COMPARED TO 4,249 IN 2020).
