ASSOCIATE MEMBERS SHALL NOT ENGAGE IN LOBBYING OR PUBLIC RELATIONS WORK RELATING TO ENVIRONMENTAL ISSUES. C. ACADEMIC MEMBER. AN INDIVIDUAL IS ELIGIBLE TO BE AN ACADEMIC MEMBER IF HE OR SHE IS ON THE FULL-TIME FACULTY OR IS A STUDENT AT AN ACCREDITED COLLEGE, UNIVERSITY, OR OTHER SCHOOL AND HAS AN INTEREST IN ENVIRONMENTAL JOURNALISM AND/OR ENVIRONMENTAL ISSUES. ACADEMIC MEMBERS SHALL NOT ENGAGE IN LOBBYING OR PUBLIC RELATIONS WORK RELATING TO ENVIRONMENTAL ISSUES. D. HONORARY MEMBER. AN INDIVIDUAL IS ELIGIBLE TO BE AN HONORARY MEMBER IF HE OR SHE HAS RENDERED OUTSTANDING AND DISTINGUISHED SERVICE TO THE SOCIETY, AS DETERMINED BY THE BOARD OF DIRECTORS. AN HONORARY MEMBER SHALL STILL HAVE ALL THE RIGHTS AND PRIVILEGES OF THE SOCIETY, EXCEPT THAT THEY SHALL NOT BE ENTITLED TO VOTE OR HOLD OFFICE. E. STUDENT MEMBER. INDIVIDUALS ARE ELIGIBLE TO BE A STUDENT MEMBER IF: 1) THEY ARE PURSUING A COLLEGE OR UNIVERSITY DEGREE OR A HIGH SCHOOL DIPLOMA AND: 2) IN THE MAJORITY OPINION OF THE BOARD OF DIRECTORS OR ITS DESIGNEE(S), THEY WILL CONTRIBUTE TO THE ATTAINMENT OF THE OBJECTIVES OF THE SOCIETY. STUDENT MEMBERS SHALL HAVE ALL RIGHTS AND PRIVILEGES OF THE SOCIETY, EXCEPT THAT THEY SHALL NOT BE ENTITLED TO HOLD OFFICE. APPLICATION FOR MEMBERSHIP. AN INDIVIDUAL SEEKING MEMBERSHIP IN THE SOCIETY AS AN ACTIVE, ASSOCIATE, OR ACADEMIC MEMBER MUST SUBMIT A COMPLETED APPLICATION, IN SUCH FORM AS THE BOARD OF DIRECTORS SHALL FROM TIME TO TIME DETERMINE. TO THE BOARD OF DIRECTORS OR A COMMITTEE OR OFFICER DESIGNATED BY THE BOARD OF DIRECTORS, WHICH, IN ITS SOLE DISCRETION, WILL GRANT OR DENY THE INDIVIDUAL'S APPLICATION FOR MEMBERSHIP. APPLICANTS WILL BE NOTIFIED IN WRITING, IF ACCEPTED, AND OF THE MEMBERSHIP STATUS GRANTED. HONORARY MEMBERS WILL BE DESIGNATED BY THE BOARD OF DIRECTORS IN ITS SOLE DISCRETION. TERMINATION OF MEMBERSHIP. THE BOARD OF DIRECTORS, BY THE AFFIRMATIVE VOTE OF TWO-THIRDS OF ALL THE MEMBERS OF THE BOARD PRESENT AT ANY REGULAR OR SPECIAL MEETING, MAY TERMINATE THE MEMBERSHIP OF A MEMBER, FOR CAUSE, AFTER AN APPROPRIATE HEARING, AND MAY, BY A MAJORITY VOTE OF THOSE PRESENT AT ANY REGULAR OR SPECIAL MEETING, TERMINATE THE MEMBERSHIP OF ANY MEMBER WHO SHALL BE IN DEFAULT IN THE PAYMENT OF DUES OR DELEGATE SUCH AN AUTHORITY TO AN APPROPRIATE COMMITTEE. MEMBERSHIP DUES. THE AMOUNT OF THE DUES OF THE MEMBERS SHALL BE DETERMINED BY THE BOARD OF DIRECTORS OR A COMMITTEE OR OFFICER DESIGNATED BY THE BOARD OF DIRECTORS AND SHALL BE PAID MONTHLY OR ANNUALLY BY SUCH DATES OR DATE AS MAY BE DETERMINED BY THE BOARD FROM TIME TO TIME. THE BOARD OF DIRECTORS OR ITS DESIGNEE(S) MAY ESTABLISH DIFFERENT DUES AMOUNTS FOR MEMBERS OF DIFFERENT CATEGORIES AND MAY FROM TIME TO TIME OFFER SPECIAL DUES DISCOUNTS.
