The Law Foundation's 80-plus attorneys, social workers and staff, together with volunteers, serve more than 10,000 individuals and families throughout Silicon Valley each year. Our Children and Youth program advances the legal rights of our youngest clients, including those in foster care, empowering them to lead healthy and productive lives. We listen to, advise, and advocate for disadvantaged children and youth to ensure their voices are heard and their rights are protected.

Our Housing program works to prevent the displacement of low-income and communities of color by providing representation and advice on housing-related matters including eviction defense, housing discrimination, tenant protections, fair conditions, and more.
