EDUCATION AND TRAINING: IN 2021 PERF HELD 4 SESSIONS OF ITS SENIOR MANAGEMENT INSTITUTE FOR POLICE (SMIP), A LEADERSHIP DEVELOPMENT PROGRAM FOR MID-CAREER POLICE OFFICIALS WHO IN MANY CASES WILL BE TOMORROW'S POLICE CHIEFS. A TOTAL OF 388 STUDENTS ATTENDED THE 2-WEEK SMIP PROGRAM.
