Women in Film & Video (WIFV) provides educational and networking opportunities for screen-based media makers, celebrates women's creative and technical achievements in media, and advocates for parity both in front of and behind the camera to ensure that all voices can be heard. A 501(c)(3) non-profit community benefit organization founded in 1979, WIFV is the premier professional resource for people who want successful media careers in the DC-metro region. Our resources, connections and advocacy support a vibrant, creative media community. The organization provides more than 120 professional development, networking, and technical skills workshops per year.

 Women in Film & Video (WIFV) provided more than 100 programs during the 2020-21 program year to satisfy the PROFESSIONAL DEVELOPMENT and GENERAL EDUCATION needs of its members and public attendees. Most members attend multiple events per program year. All WIFV programs are open to the general public and we had more than 2000 non-members attend the Wednesday Ones, Roundtables, master classes, special interest workshops, and ScriptDC. The meetings present industry leaders who share their insights and provide attendees with info to hone their skills to become better freelancers, employers and employees. Professional development programs were hosted online due to COVID-19 from July 1, 2020 to June 30, 2021. We found a broader geographic representation since attendees didn't have to deal with commuting. WIFV nominates films annually for inclusion into the National Film Registry. WIFV continues its fiscal sponsorship program to support women-created media and added new projects to that program.

 Women in Film & Video (WIFV) offers NETWORKING opportunities at all events and provided several specific networking events to aid members in making connections across the Mid-Atlantic media industry. WIFV hosted a Fall Open House, Holiday Party, and more informal events provide a range opportunities for new and existing members to network with each other and non-members, quadrupling the networking events we typically offer. With rare exceptions, all networking events were held online from July 1, 2020 through June 30, 2021. We were unable to hold the Annual WIFV Media Job Fair due to COVID-19 prohibitions of public gatherings of more than 10. Networking events were held specifically for caregivers and BIPOC mediamakers on a monthly basis.

 Women in Film & Video (WIFV) distributed a member E-NEWSLETTER 11 times, a MEMBERS IN THE NEWS E-NEWSLETTER 12 times, a MONDAY MISSIVE 50 times for its 900+ members and the 3000+ non-members who have signed up for e-newsletter delivery. The e-newsletter promotes member accomplishments, introduces new opportunities and research, and informs readers about professional development and educational offerings from WIFV and other media organizations. The e-newsletter and members in the news are archived on the WIFV website for general public access. The e-newsletter has dramatically increased the amount of information it presents because of the electronic format and now includes live links to information and members profiled making the material even more accessible via search engines. The weekly MISSIVE provides breaking news and event announcements.

 Women in Film & Video (WIFV) Members typically provide valuable COMMUNITY OUTREACH FOR CHILDREN about media literacy through the KIDS WORLD FILM FESTIVAL (KWFF) for DC, Maryland and Virginia 5th graders and their teachers. The students receive media literacy training at their schools and participate in a film festival featuring a selection of short films from around the world that focused on issues of tolerance, conflict resolution and diversity. While we planned to offer the program in 2020-21, COVID made that impossible, thus the minimal expenses for the program in the fiscal year reported.
