PARTICIPANTS GATHER ON THE NATIONAL MALL FOR A RALLY INCLUDING REMARKS, VIDEOS, AND MUSIC FROM A VARIETY OF CULTURAL LEADERS - POLITICAL, RELIGIOUS, SPORTS, ENTERTAINMENT, STUDENTS, ETC.
