IN 2021, WE TRAINED 146 NEW FACILITATORS IN SMART RECOVERY TOOLS, TECHNIQUES, AND MEETING FACILITATION METHODS. WE ALSO TRAINED 543 TREATMENT PROFESSIONALS TO USE SMART RECOVERY IN THEIR TREATMENT OF INDIVIDUALS STRUGGLING WITH SUBSTANCE USE DISORDER.
