4a (Code: ) (Expenses \$ 151,142 including grants of \$ ) (Revenue \$ ) Each year, Camp Opportunity volunteers plan and implement a themed, week-long residential summer camp for 40 abused/neglected children (ages 8 - 11) from Central Maryland (due to Covid limitations in 2021, 32 campers attended). The camp is unique in that it pairs children 1 to 1 with their own trained counselor for the entire week. This provides care and attention that is oftentimes missing in these children's day to day lives. The week is infused with daily lessons that teach resilience, empowerment and life skills to help them navigate difficult situations in a more positive manner. Interim activities (every other month) and monthly Zoom get-togethers are held with counselors and campers. The organization conducts a graduation picnic in June of every year to celebrate campers who have completed their four years of camp and targeted year-round programming.
