THE TORRES DEL PAINE LEGACY FUND IN CHILEAN PATAGONIA HAD NUMEROUS ACCOMPLISHMENTS INCLUDING THE INSTALLATION OF TWO WATERLESS, COMPOSTING ECO-TOILETS IN BACKCOUNTRY CAMPGROUNDS; GRANTING \$16,500 IN PANDEMIC RECOVERY FUNDS TO SUSTAINABLE TOURISM BUSINESSES; COMPLETION OF A SUSTAINABLE AND INTERPRETIVE HIKING TRAIL; AND HIRING OF A LOCAL RESIDENT AS DIRECTOR OF THE PROGRAM. THIS VIRTUAL EVENT, ATTENDED BY 270 INDIVIDUALS FROM AROUND THE WORLD, FOCUSED ON HELPING KEY SECTORS BRIDGE THE DISCONNECT BETWEEN THE GOALS THEY ARE WARNED MUST BE MET WHEN IT COMES TO MITIGATING THE CLIMATE CRISIS AND THE ACTION STEPS THEY CAN TAKE TO DO SO.
