In 2021, Working Bikes collected 10,844 used bicycles with the help of many bike collection events, often in conjunction with municipally supported recycling fairs, and provided information on safe-riding, basic bike repair, and recycling at dozens of community events. Countless individuals and entities including bike shops, property companies and police departments were donation drop off" partners for unwanted bicycles to be repurposed by Working Bikes. Hundreds of volunteers donated thousands of hours to Working Bikes in 2021 and facilitated the donation of 6,732 bikes (15 shipping containers) of used bicycles to our international partners in Africa, Central America and Middle Eastern countries. Volunteers and staff also repaired and distributed bikes to individuals and organizations in need of transportation.
