We planted 12 apple and 2 peach trees at the Milbridge Commons. 100% of participants who participated in a feedback survey said the workshops were excellent. Around 30 pumpkins planted with the elementary school at the garden next to the Red Barn Motel. Approximately 8000 lb of vegetables were grown. 1 15 x 25 greenhouse was installed behind WHRLs office. 75 families across Washington County were sent seeds to start a vegetable garden as part of the Downeast Family Seed Project. Our gardening blog, Seeds & Sprouts, started. We posted 11 posts.
