KCMS Foundation then coordinates that healthcare in partnership with Federally-Qualified Health Centers and safety-net clinics across the metro.

Facts And Circumstances Test

Sources of Support: More than 10% of the organization's support comes from government units and/or the general public. The organization is developing additional support from the public through annual giving campaigns and government contracts and grants. This is a long-term strategic goal of the organization, in which the organization is investing leadership and staff time. KCMS Foundation programs have served the Kansas City metro area since 2006, helping a broad population of uninsured and underserved people access healthcare. Twenty-seven safety-net clinics, ten hospitals/health systems, and over nine hundred physicians support the agency's mission through collaboration for care and donation of healthcare services. Representative Governing Body: KCMS Foundation maintains a representative governing board that represents the broad interests of the public. Several criteria are used to ensure that public interest is represented. Board members are selected to represent communities across the metro to provide special knowledge and expertise in the area of safety-net healthcare, health access and equity, and to represent the population served and the broader community. Availability of Public Facilities or Services and Public Participation: KCMS Foundation provides access to over \$8,000,000 annually in donated, free healthcare to people who are uninsured and medically underserved in a five-county area. In addition, the organization's volunteers provide access annually to over \$10,000 in free community health education services. Over 900 physicians with specialized knowledge and expertise participate in donation of healthcare and health education programming annually through our WyJo Care, Metro Care, Retired Physician Organization, and Wellness and Prevention programs, which serve to accomplish the charitable work of the organization. The organization is held accountable for grants provided through philanthropic sources. These grants, whether from public or private sources, and made to support charitable programs that support a broad section of the population; those who are uninsured and medically underserved. KCMS Foundation is held accountable by our donors and board of directors for the appropriate use of these funds, and for ensuring that charitable service goals are met.
