DUE TO A SURGE IN THE COVID-19 DELTA VARIANT, 2021 PRIDE FESTIVAL ACTIVITIES HAD TO BE CANCELLED. PRIOR TO THE COVID-19 PANDEMIC, THE ATLANTA PRIDE FESTIVAL AND PARADE PROVIDED A PLACE FOR HUNDREDS OF THOUSANDS OF PEOPLE TO CONNECT WITH ONE ANOTHER AND WITH NECESSARY SERVICES FROM LGBTQ+ SERVING ORGANIZATIONS. IN 2021, CANCELLATION OF THE IN-PERSON ATLANTA PRIDE FESTIVAL AND PARADE MEANT THAT COMMUNITY ORGANIZATIONS WOULD NEED TO RETHINK HOW THEY REACHED COMMUNITY MEMBERS WHO NEED THEIR SERVICES. THE APC'S PRIDE IN ACTION AND COMMUNITY REINVESTMENT GRANTS (CRG) PROVIDE FUNDING AND RESOURCES TO FELLOW COMMUNITY ORGANIZATIONS THAT ALIGN WITH THEIR MISSION AND STRATEGIC GOALS. THE APC IS COMMITTED TO LENDING THEIR SUPPORT TO THOSE WORKING TO UPLIFT THE MOST VULNERABLE MEMBERS OF ATLANTA'S LGBTQ+ COMMUNITY.
