HAPPY TAILS VOLUNTEERS SHARE THE UNCONDITIONAL LOVE OF THEIR PETS WITH PEOPLE OF ALL AGES WITH PHYSICAL, SOCIAL, EMOTIONAL AND COGNITIVE NEEDS AT HEALTHCARE FACILITIES, SOCIAL AGENCIES AND SPECIAL NEEDS PROGRAMS THROUGHOUT THE METRO ATLANTA COMMUNITY.

28 HAPPY TAILS IS OPERATED BY A VOLUNTEER BOARD, COUNSELED BY A VETERINARY ADVISORY BOARD AND SUPPORTED BY AN ADVISORY BOARD OF LOCAL PROFESSIONALS. RECRUITING NEW MEMBERS/PET TEAMS HAPPY TAILS CONTINUES TO WORKS TO EXPAND ITS MEMBERSHIP OF HUMAN AND COMPANION ANIMAL VOLUNTEER TEAMS IN ORDER TO MEET THE GROWING NEED FOR ITS PET THERAPY SERVICES. DESPITE THE ESTIMATED ACHIEVEMENT OF 22% INCREASE IN THERAPY INTERACTION HOURS OVER THE PAST YEAR, WE DO NOT HAVE ENOUGH MEMBERS TO MEET THE GROWING NEED FOR PET THERAPY SERVICES. THERE ARE MORE THAN 150 FACILITIES THAT HAVE APPLIED FOR AND ARE WAITLISTED FOR HAPPY TAILS TEAMS TO BEGIN VISITING. EXPANSION PLANS REQUIRE ADDITIONAL RESOURCES TO SUPPORT RECRUITING EFFORTS, PET-HANDLER EVALUATIONS, MEMBER ORIENTATION AND ONGOING TRAINING, TEAM LEADER TRAINING, QUALITY MONITORING AND IMPROVEMENT OF THE SERVICES WE PROVIDE. THE BOARD MONITORS RECRUITING EFFORTS, AND MEASURES THE NUMBER OF ATTENDEES AT ORIENTATION SESSIONS, WHICH IS THE FIRST STEP TO MEMBERSHIP. ADDITIONALLY, THE BOARD OVERSEES MEMBERSHIP ACTIVITIES AND INTERACTIONS TO ENSURE RETENTION OF VISITING TEAMS. FINANCIAL STRENGTH THROUGH IMPROVED FUND RAISING HAPPY TAILS WORKS TO MAINTAIN A STRONG FINANCIAL POSITION WHICH ENABLES IT TO CONTINUE TO ACCOMPLISH ITS MISSION. THESE ACTIVITIES INCLUDE A 6TH ANNUAL 5K RACE/FUN RUN IN 2020 WHICH WAS ONLINE DUE TO COVID PROTOCOLS, AND DONATIONS BY ITS MEMBERSHIP THROUGH ANNUAL DUES. OUR HUMAN AND ANIMAL VOLUNTEERS ARE ALSO GOODWILL AMBASSADORS AS WE OFTEN RECEIVE DONATIONS IN WHICH A PERSON IMPACTED BY A VISIT, FAMILY MEMBER, FRIEND OR FACILITY RECOGNIZES THE SPECIAL IMPACT OF A HAPPY TAILS' VISIT. BUILDING STRONGER RELATIONSHIPS WITH THE FACILITIES WE SERVE HAPPY TAILS SEEKS TO CREATE SUPPORTIVE POSITIVE RELATIONSHIPS WITH THE FACILITIES WE SERVE. HAPPY TAILS TEAMS CREATE INTERACTIONS WITH THE FACILITY PATIENTS, CLIENTS AND STAFF THAT CONTRIBUTE TO THE FACILITY MISSION.
