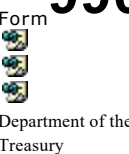

THE ORGANIZATION'S CORE PROGRAMS ARE: 1) THE WELLNESS PROGRAM, WHICH PROVIDES AFFORDABLE, QUALITY HEALTHCARE SERVICES TO THE MEDICALLY UNDERSERVED, HEALTH EDUCATION AND LINKAGE TO LOW COST MAMMOGRAPHY SERVICES; 2) ATLANTA HEALTHY START, WHICH PROVIDES HOME-BASED CASE MANAGEMENT SERVICES AND HEALTH EDUCATION TO PREGNANT AND POSTPARTUM WOMEN; AND 4)THE WOMEN'S ECONOMIC SELF SUFFICIENCY PROGRAM, WHICH PROVIDES MICRO-BUSINESS TRAINING TO LOW-TO-MODERATE INCOME WOMEN.

CASE MANAGERS PROVIDE HOME VISITATION TO PREGNANT WOMEN, LINKING THEM TO PRENATAL CARE AND OTHER IMPORTANT SERVICES, AND PROVIDE HEALTH EDUCATION AND PARENTING SKILLS UNTIL THE BABY TURNS 18 MONTHS OLD. IN 2021, ATLANTA HEALTHY START SERVED A TOTAL OF 461 PARTICIPANTS, INCLUDING 240 PREGNANT AND POSTPARTUM WOMEN AND 153 CHILDREN AGES 0-18 MONTHS, AND 68 FATHERS.
