IN 2021, OUR GRASSROOTS BASE OF OVER 43,000 EMAIL ACTIVISTS AND OVER 21,000 TEXT ALERT SUBSCRIBERS SENT EMAILS AND MADE PHONE CALLS TO THEIR DECISION-MAKERS ON ISSUES SUCH AS CLIMATE CHANGE, FOREVER CHEMICALS IN OUR WATER, AND CLEAN ENERGY. NC CONSERVATION NETWORK WORKS TO INCREASE AWARENESS OF-AND PROVIDE WAYS TO TAKE ACTION ON-KEY ISSUES IMPACTING THE HEALTH OF OUR STATE THROUGH SOCIAL MEDIA.
