OUR EFFORTS WERE FOCUSED ON MOBILIZING TRANS YOUTH AND THEIR PARENTS TO PUSH BACK AGAINST THIS HARMFUL LEGISLATION. OUR EFFORTS ARE CONTINUING AS WE EDUCATE AND PREPARE TO PUSH BACK AGAINST ANTI-TRANS LEGISLATION IN THE FUTURE. - OUR STATEWIDE TRANSACTION FLORIDA NETWORK NOW CONSISTS OF OVER 1,200 MEMBERS FORMING A STATEWIDE MOVEMENT TO INCREASE AWARENESS OF THE TRANSGENDER AND NONBINARY COMMUNITY AND TO SHARE INFORMATION AND RESOURCES ACROSS THE STATE. - INITIATED A TRANSACTION PARENT NETWORK TO SUPPORT PARENTS OF LGBTQ+ CHILDREN IN THE STATE OF FLORIDA TRANS ACTION HAS PARTICIPATED IN AND/OR HELPED COORDINATE MULTIPLE LISTENING SESSIONS FOR TRANSGENDER AND NONBINARY YOUTH AND LEADERS INCLUDING THOSE HOSTED BY THE WHITE HOUSE, DEPARTMENT OF HOMELAND SECURITY AND THE DEPARTMENT OF EDUCATION.
