THROUGH A STUDENT-CENTERED APPROACH, WE MOTIVATE AND INSPIRE YOUTH TO DEVELOP PERSONAL RESPONSIBILITY AND SELF-GOVERNANCE. OUR STUDENT LEADERS AIM TO BECOME LEADERS IN TRAINING FOR EXCELLENCE (L.I.T.E.). L.I.T.E. TEENS ARE THE LEADERS OF LEADERS. THROUGH A VARIETY OF ACTIVITIES, EXPERIENCES, AND COMMUNITY SERVICE, STUDENTS ADOPT CHARACTER TRAITS AND SKILLS NECESSARY TO BE SUCCESSFUL. OUR TEEN PROGRAM AIMS TO KEEP STUDENTS ENGAGED THROUGH HIGH SCHOOL GRADUATION. LEADERSHIP DEVELOPMENT IS AT THE CORE OF HOW THE PROGRAM OPERATES. OUR PROGRAMS DEVELOP TEAMWORK, SOCIAL SKILLS AND FOSTERS SOCIAL AND EMOTIONAL GROWTH. STUDENTS LEARN THE HARD AND SOFT SKILLS NECESSARY TO BE SUCCESSFUL IN LIFE AND IN THE WORKPLACE. AS PART OF THE PROCESS OF BECOMING L.I.T.E. OUR TEENS PARTICIPATED IN THINK AND GROW RICH MASTER MIND SESSIONS FACILITATED BY OUR EXECUTIVE DIRECTOR. OUR STUDENT LEADERS ACQUIRE JOB EXPERIENCE WHILE FOCUSED ON FORMING MEANINGFUL RELATIONSHIPS WITH PEERS AND THE COMMUNITY. AS PART OF FGCU'S CROP, STUDENTS EXPLORE CAREER PATHS AND BUSINESS VENTURES THROUGH ONGOING PROJECT-BASED LEARNING ACTIVITIES. IN ADDITION, OUR STUDENTS ATTEND THE DEPARTMENT OF JUVENILE JUSTICE (DJJ) CAREER EXPLORATION IMPACT SERIES. SUMMER CAMP'S IMPACT SERIES VIRTUAL SESSION WAS FOCUSED ON THE CONSTRUCTION INDUSTRY. STUDENTS THAT MAKE ACADEMIC IMPROVEMENTS, PARTICIPATE WITH GOOD BEHAVIOR, AND HAVE CONSISTENT ATTENDANCE ARE ELIGIBLE TO WORK WITHIN THE ORGANIZATION IN FOOD SERVICES, SPECIAL EVENTS, LOGISTICS, TUTORING, FRONT DESK, INFORMATION TECHNOLOGIES, SOCIAL MEDIA AND/OR SUMMER CAMP. WE HIRE L.I.T.E. TEENS THAT WANT TO EARN WHILE THEY CONTINUE TO LEARN. WE CURRENTLY HAVE 3 TEENS THAT ARE EMPLOYED BY THE QUALITY LIFE CENTER. WE HAVE A TEEN EMPLOYED IN OUR AFTERSCHOOL ACE PROGRAM AND LOGISTICS, INFORMATION TECHNOLOGY (IT), AND FRONT DESK AND OFFICE SUPPORT. IN ADDITION WE HAVE A TEAM OF TEENS THAT ARE GIVEN CONTINUOUS OPPORTUNITIES WORK SPECIAL EVENTS THAT ARE HOSTED AT OUR TEEN CENTER. DURING SUMMER CAMP THE QUALITY LIFE CENTER EMPLOYED 13 TEENS IN A VARIETY OF POSITIONS THAT INCLUDE FOOD SERVICE, FACILITY MAINTENANCE, SUMMER CAMP GROUP LEADERS, AND INSTRUCTORS. WE EXPECT TO HIRE 3 TO 5 MORE TEENS BEFORE THE END OF THE FALL SEMESTER. THE ARTS AND EDUCATION COMPONENTS OF THE PROGRAM ENSURE STUDENTS DEVELOP HEALTHY SOCIAL-EMOTIONAL SKILLS AND MAKE CONSISTENT ACADEMIC IMPROVEMENTS. STUDENTS RECEIVE INSTRUCTION IN VISUAL ARTS, DANCE, DRAMA, AND MULTIMEDIA. DURING SUMMER CAMP OUR STUDENTS LEARNED CHOREOGRAPHY TO THE GREAT RETRIBUTION. THE GREAT RETRIBUTION WAS OUR "BIG SHOW" FOR 2021. BECAUSE OF COVID WE HAD TO POSTPONE OUR ANNUAL PERFORMANCE, HOWEVER, OUR STUDENTS HAVE BEEN PERFORMING AT LOCAL COMMUNITY EVENTS. OUR STUDENTS RECENTLY PERFORMED AT EDISON MALL'S TEACHER APPRECIATION DAY. AS PART OF THIS PARTNERSHIP WITH EDISON MALL, WE HAVE BEEN INVITED TO PERFORM AT THEIR ANNUAL HALLOWEEN COMMUNITY CELEBRATION, SANTA PARADE, AND THE 2022 MARTIN LUTHER KING CELEBRATION. OUR ARTS ACTIVITIES ENCOURAGE FINE MOTOR SKILLS, NEURAL DEVELOPMENT, AND PROBLEM-SOLVING ABILITIES THAT CONTRIBUTE TO ACADEMIC GAINS. OUR STUDENTS HAVE BEEN MAKING ART PIECES THAT WILL BE AUCTIONED AT OUR GALA EVENT IN NOVEMBER. OUR STUDENTS RECEIVE ACADEMIC INSTRUCTION IN READING, SCIENCE, TECHNOLOGY, ENGINEERING, AND MATH. STUDENTS ALSO RECEIVE HOMEWORK ASSISTANCE AND TUTORING. IN ADDITION, STUDENTS RECEIVE COLLEGE READINESS SERVICES AND PARTICIPATE IN EXPERIENCES THAT INCLUDE TRIPS TO COLLEGES AND UNIVERSITIES, STANDARDIZED TESTING TUTORING, FINANCIAL AID/FAFSA ASSISTANCE, AND COLLEGE APPLICATION ASSISTANCE. DURING SUMMER CAMP, OUR TEENS WENT TO FLORIDA GULF COAST UNIVERSITY (FGCU), HODGES, AND PARTICIPATED IN A FACILITATED VIRTUAL TOUR OF FORT MYERS TECHNICAL COLLEGE. LAST YEAR, OF THE ACE STUDENTS WHO COMPLETED THE PROGRAM: 76% INCREASED THEIR MATH SKILLS OR MAINTAINED AN A OR B GRADE LEVEL. 91% INCREASED THEIR READING SKILLS OR MAINTAINED AN A OR B GRADE LEVEL. 92% INCREASED THEIR KNOWLEDGE AND DEMONSTRATION OF POSITIVE BEHAVIOR, TEAMWORK & SOCIAL SKILLS.
