The CIW provides community education, leadership development, technical assistance and information on legal and human rights so as to promote greater justice, equality and unity. Form 990, Page 2, Part III, Line 4a (Program Service Accomplishments): Community Education and Outreach, Leadership Training and Development, and Advocacy for Civil and Human Rights: Held weekly and monthly meetings to discuss human rights and community issues with an average attendance of 70 people, produced community theater and art addressing community issues, conducted extensive media outreach, held educational meetings at labor camps, and distributed labor rights booklets there and elsewhere. Broadcast educational programming on radio, PSAs. Hosted and attended public meetings locally, state-wide, and nationally to raise awareness of farm worker issues and campaign for protecting their human rights and creating humane working conditions. Organized festivals to focus attention on farm worker issues. Conducted worker education on-site at farms in dozens of counties across an 8-state area, focusing on rights and responsibilities under the Fair Food Program and the law, educating thousands of workers. Held local, statewide and national education trainings covering topics including human rights, health education, English language instruction, theater production, art production, radio program planning, logistics, planning techniques for community meetings and community action campaign with hundreds in attendance. Some notable achievements specifically in 2021 included: New farms joined CIWs Fair Food Program in Tennessee and North Carolina, expanding human and legal rights protections for farmworkers, and CIWs farmworker education team visited both new farms (along with others in the Fair Food Program) to educate farmworkers there on their rights. CIW collaborated with Partners in Health and the Healthcare Network to help address COVID-19 in the Immokalee community through educational efforts, including providing extensive support for vaccination efforts in the community. CIWs Fair Food Program added additional protections against heat stress for farmworkers, and CIW educated farmworkers on those new rights. The Anita Hill-led Hollywood Commission announced a collaboration with CIW to educate the entertainment industry about effective solutions to combat abuse in Hollywood in the wake of #MeToo.</p>
