HIV Programs - Spahr offers both HIV Care Services and HIV Prevention Services. HIV Care services include benefit advocacy, case management, emergency financial support, mental health support, food and transportation for low-income HIV-positive Marin County residents. HIV Prevention Services includes HIV testing and navigation to bio-medical HIV prevention, including post-exposure prophylaxis (PEP) and pre-exposure prophylaxis. Spahr serves approximately 220 clients in this program area.

Harm Reduction - Services provided by Spahr include syringe access, safe needle exchange, naloxone distribution and hepatitis C testing and linkage to care. Spahr offers peer to peer support. Interventions in 2021 was 2,217

Youth Programs & Services - Includes discussion groups, mental health support services, online and in-person social events, training of educators on Allyship with LGBTQ+ youth and advocacy in Marin County schools to improve school culture and support for LGBTQ+ students. Spahr also offers support groups for anyone raising trans/non-binary/gender questioning children focused on sharing of experiences in a safe place where members can explore how best to support their child.
