Pro bono legal services to Muslims who have faced discrimination as a result of their race, religion, and ethnicity. During 2021, CAIR WA approximately assisted 129 clients. Additionally, we received over 700 requests for help through our Afghan legal clinic for immigration-related services.

Community advocacy and education via know your rights presentations and virtual events are provided at no cost to the Muslim community throughout the state of Washington. By making sure the community members are educated on their rights as well as issues of Islamophobia, CAIR WA hopes to create an empowered network of Muslim families, youth, children, and elders who use their voices to combat anti-Muslim hate. During 2021, CAIR-WA conducted 33 informative live online events - navigating the constraints of the ongoing COVID-19 pandemic with consistent virtual programming for our diverse community.

Communications and media work to ensure an accurate representation of Muslims in mainstream media that is both accurate and culturally sensitive. We also have a youth engagement program through which we mentor approximately 20 Muslim teenagers. There were at least 4 mosques that were targeted in Washington State in late 2021, therefore CAIR-WA provided our services to ensure that there was media awareness about these incidents as well as lending legal and advocacy support the targeted facilities.
