ACCESS TO HIGH-QUALITY EARLY CHILDHOOD EDUCATION IS ESSENTIAL TO THE FUTURE SUCCESS OF BABIES, TODDLERS, AND THEIR FAMILIES. CHILDREN WHO ARE NOT PREPARED TO START SCHOOL AT AGE 5 ARE AT RISK OF NEVER CATCHING UP, LEAVING AN ACHIEVEMENT GAP THAT CAN PERSIST THROUGHOUT THEIR ENTIRE LIVES. AS THE EARLY HEAD START PROVIDER IN OKLAHOMA CITY, SUNBEAM IS A LEADER IN EARLY CHILDHOOD EDUCATION. THE GOALS OF SUNBEAM'S EARLY CARE AND EDUCATION PROGRAM ARE HIGH-QUALITY LEARNING EXPERIENCES, STRONG FAMILIES, AND GOOD HEALTH AND WELL-BEING.
