ORIGINALLY STARTED AS A SUMMER CAMP PILOT PROGRAM AND HAS SINCE GROWN INTO A MULTI-SERVICE PROGRAM IMPACTING YOUTH IN FIRST THROUGH EIGHTH GRADE AT THREE CAMP SITES.
