The mission of Christian Community Service Center, Inc. (CCSC) is to serve the poor, hungry, disabled and otherwise needy while respecting their religious, ethnic, or cultural differences.

 Emergency Services operates 2 locations in Central and Southwest Houston. The program provides food, financial assistance and referrals to residents of 29 zip code areas of Houston. Financial assistance is targeted to help with a family's rent, utilities, prescriptions or other medical needs. Services were provided to 33,452 (duplicated) people in crisis during 2021.

**4b** (Code: ) (Expenses \$ **312,353** including grants of \$ **4,558** ) (Revenue \$ )  
 JobNet assists the unemployed in conducting an effective job search. In 2021, 270 people were helped.

**4c** (Code: ) (Expenses \$ **296,883** including grants of \$ **238,726** ) (Revenue \$ )  
 Back to School provides disadvantaged students with grade-appropriate school supplies and new clothing at the start of each school year. A total of 6,802 students received assistance in 2021.

(Code: ) (Expenses \$ **214,544** including grants of \$ **9,625** ) (Revenue \$ )  
 Martha's Way is a 42-hour curriculum that teaches participants to become small business owners in the field of domestic housecleaning. During 2021, 177 students were aided on their road to vocational success.

(Code: ) (Expenses \$ **105,030** including grants of \$ **2,612** ) (Revenue \$ )  
 Home Caregiver Training is a 50+ hour curriculum that provides training in the field of caring for older adults. During 2021, 20 students graduated from our class.

(Code: ) (Expenses \$ **71,070** including grants of \$ **15,325** ) (Revenue \$ )  
 Jingle Bell Express collects, purchases, and provides food, toys, and books to needy local area families during the Christmas holiday season. A total of 1,741 children were aided through this program in 2021.

 The Louise J. Moran Vision Care program provides eyesight screening, professional eye exams and glasses to children free of charge. In 2021, 178 children received professional eye exams with 161 of them receiving new prescription glasses. This was only offered in the fall semester due to the pandemic.
